Disturbing Behavior	Ideation is Present - Student impacted by situational stressors or traumatic events - Emotionally troubled - Vague and indirect threat(s) - Threat lacks realism - Threat content suggests person is unlikely to take action	Low Risk - Does not appear to pose a threat of violence or self-harm at this time - Is not causing a significant disruption in the community - Need for evaluation, intervention, and/or monitoring.	- Establish monitoring protocol (active or passive) - Consider referral to Counseling & Wellness Services, University Police, Student Support Services, Community Standards and Student Conduct - Consider situation as educational opportunity for campus community - Consider Care and Concern Meeting and/or Health and Wellness Conference		
Disruptive Behavior	Planning - Disruptive &/or bizarre behavior - Destructive &/or threatening behavior - Wording of threat suggests consideration on how to implement threat - General indication of time and place associated with threat - Statements made to indicate commitment to behavior as an alternative: "I'm not kidding"	Moderate Risk - Exhibits behaviors likely to be disruptive to the community - Does not pose an imminent threat at this time - Need to intervene, refer, evaluate and monitor	- Initiate active monitoring - Referral to Community Standards and Student Conduct - Evaluate need for parent/guardian notification - Initiate Health and Wellness Conference		
Threat of Harm	Preparation - Strong suicidal ideation - Hostile, aggressive, &/or abusive behavior - Unable to regulate emotions - Engaging in risk taking behaviors - Indication that the student is preparing to implement plan	High Risk - Appears to pose a threat of harm to self or others, usually toward a target that is identified but lacks immediacy or has a specific plan but not an identified target.	- Monitor closely - Notify WSU Police - Notify parent/guardian - Notify anyone who may be at risk - Consider administrative withdrawal process - Initiate Health and Wellness Conference - Consider situation as educational opportunity for campus community		
Imminent Threat	Implementation - Specific and plausible plan - Statements convey steps taken to carry out plan - Recently acquired or practiced with weapon - Recent surveillance of potential victim - Giving away valued items	Imminent Risk - Appears to pose immediate threat of serious harm/violence to self, others or structures.	- Notify WSU Police - Notify parent/guardian - Notify anyone who may be at risk - Consider administrative withdrawal process - Initiate Health and Wellness Conference
